What is WIOA?

The Workforce Innovation & Opportunity Act (**WIOA**) is designed to help job seekers access employment, education, training, and support services to succeed in the labor market and to match employers with the skilled workers they need to compete in the global economy. It helps job seekers, including young adults and those with significant barriers to employment, prepare for the labor market and find high-quality jobs and careers.

WIOA ensures that employment and training services provided by the core programs are coordinated and complementary so that job seekers acquire skills and credentials that meet employers' needs.

- Provide participants with paid work experience to develop positive work habits and ethics
- Provide participants opportunities to explore a variety of employment pathways
- Provide participants with vocational and occupational counseling
- Motivate and assist participants in their efforts to succeed in higher education


